Survey Response Summary

In an effort to gather opinions regarding the bylaws, the college surveyed by email all alumni who are contactable, the student body, faculty, staff and former faculty. The recipients also received multiple follow-up communications before the survey closed.

At the close of the survey period (Nov. 5 through Jan. 22), the college had received more than 4,000 completed responses. The trustees considered the college community's responses among other feedback before making a decision about the bylaws at their January meeting.

Of the more than 17,000 contactable alumni, 3,625 alumni and current students

responded; the remaining responses came from faculty, staff and faculty emeriti.

The survey consisted of five sections, including an introductory video, demographic information, questions related to values and traditions important to Davidson, questions about the bylaws under consideration, and open-ended questions that invited respondents to share additional opinions.


Thank you to all who took time to complete the survey. The Board of Trustees reviewed all survey data and appreciates the thoughtful responses from the Davidson community.

QUESTION:

What do you value about Davidson College?

The first opinion question in the survey provides a selection of Davidson values and traditions. While there are differences of opinion in some parts of the survey, it is also remarkable how aligned the responses to this question are. There is much the Davidson community agrees is important for the future success of the college.

- 97.5% of all respondents value the relationships formed with students, faculty, staff and alumni
- 99.5% of all respondents somewhat or highly value the strength of the academic program
- 96.5% of all respondents somewhat or highly value the student-run Honor Code





Tradition can be improved upon proper examination. Throughout history, it has been this way and will continue to be. To disavow it without consideration or out of a loathing of its very existence is anothema to the values we hold dear. Davidson stands upon the shoulders of its rich tradition. May its past guide its future, without the wholesale abandonment of its history as seen in far too many institutions today.



QUESTION:

How important to the future success of the college are the following commitments?

There is considerable agreement from all respondents on the seven commitments included. Of note are the following observations:

- 94.8% value a commitment to access and affordability
- 97.1% value a commitment to leadership and service
- 93.2% value a commitment to the development of humane instincts
- 99.7% value honesty, integrity and trust
- 99.6% value intellectual rigor, academic exploration, and the development of creative minds



One of the things, perhaps *the* thing, that has made Davidson unique has been its ability to change and adapt over the years while protecting, maintaining and living its core values—a balancing act in today's world of no small significance. While so much has changed since I walked the campus some 55 yrs. ago, that "Davidson intangible" when I set foot on campus today is still the same, and I know I'm home.





QUESTION:

How important is it that the college president be an active Christian affiliated with a PC(USA) congregation, and specifically an active member of Davidson College Presbyterian Church?



While survey responses varied based on different generations, this view shows the data in aggregate.

The founding values of Davidson College are beautiful and aspirational principles. But Presbyterians—or even Christians—do not hold a monopoly on honor, service, humane instincts, respect, or the rigorous pursuit of truth. In fact, limiting a significant number of the College's most important leaders to a particular denomination deprives the College of the talents and strengths of so many potential leaders who share the College's values but do not happen to share its historical religious affiliation. More candially, I'm not sure the College can profess to aspire to diversity, equity, and inclusion while also maintaining that only one narrow profile of person is fit to lead it. So which'll it be? I believe it's possible to honor where we came from without closing off the world we find ourselves in now.
